While VisaCenter ensures that information is made available to the visa applicant promptly and accurately, the Visa Applicant shall at all times be responsible for providing and maintaining an SMS text compatible mobile phone number where VisaCenter can send text messages regarding the status of the Visa Application to the Visa Applicant. The Visa Applicant is responsible for ensuring connection to a mobile network capable of receiving the SMS Services. The Visa Applicant understands that if The Visa Applicant 's mobile phone is switched off, disconnected for any reasons or is out of coverage for a period of 24 hours or more, The Visa Applicant's mobile network provider may delete any SMS messages to be received by The Visa
- 2. REGISTRATION WITH US EMBASSIES

The world unfortunately is not a safe place. When you travel abroad and surrounded by foreign environment many situations, in some cases hostile may arise, like terrorist attacks, banditry or even war. Plus there are natural disasters and catastrophes.

Visacenter.us can help you to make your contact information in the country where you are traveling available to US Embassy/Consular officials responsible for helping Americans abroad.

What is the registration?

Upon your request the Department of State in Washington DC will be provided with your major contact information in the country of your travel. In the event there is a need to contact Americans to offer urgent advice or evacuation during a natural disaster or civil unrest, US Embassy/Consulate contacts all registered US citizens in that country. U.S. consular officers assist Americans who encounter serious legal, medical, or financial difficulties.

OFFICIAL REGISTRATION IS RECOMMENDED for **ALL Americans** traveling abroad for business or pleasure, or residing abroad, irrespectively of the length of travel.

It is best to register **BEFORE** the start of the trip.

What should I do to register?

To register, you are required to fill-out short US Embassy Registartion Request Form with your basic contact and travel information.

Tanzania Visa Requirements

- Original, signed United States passport with at least 6 months of remaining validity.
- Filled-out and signed Tanzania visa application form.
- Two passport-type photos.
- Copy of the flight and hotel booking. Get them now at -WWW.FLIGHTBOOKINGFORVISA.COM
- Note: Holders of Travel Documents, Certificates of Identity, refugees and nationals of the following countries shall have their visa applications referred to Tanzanian Immigration Services, for approval before visa is processed: Afghanistan, Abkhazia, Azerbaijan, Bangladesh, Chad, Djibouti, Ethiopia, Equiatorial Guinea, Eritrea, Lebanon, Mali, Mauritania, Morocco, Niger, Palestine, Refugess and Stateless individuals, Senegal, Somalia, Sierra Leone, Tajikistan, Turkmenistan, Uzbekistan, Kazakhstan, Kyrgyzten, and Sri Lanka. The processing period varies from case to case. No expedited services for referred visa applications.
- Persons with dual citizenship, one of which is US, must apply with their US passports only. Applicants with other than US passports must provide the copy of the document confirming their current resident status in USA

Tanzania Business Visa Requirements (additionally to the requirements above)

• Business Letter. A business letter from either the sending company in the US or sponsoring company in Tanzania. The letter should be printed on company letterhead stationery, addressed to the Embassy of Tanzania, and signed by a senior manager (an equivalent to Vice-President or above). Business letters from US companies should adhere to the following guidelines: ? Briefly introduce the applicant (please specify employment status/position held in the company by applicant). ? State the nature of the business to be conducted (ie. business meetings, contract negotiations, etc.) and the names and addresses of companies to be contacted in Tanzania. ? Specify the type and desired validity of the visa (ie. one year multiple entry business visa). ? Guarantee of sufficient funds for travel.
